Whereas, we pause to remember all those who have lost their lives and who have suffered permanent disabilities defending their communities and the rule of law and the thoughts and prayers of the MCBL&F are with all individuals of our law enforcement community and their families;

Whereas, members of law enforcement have been adversely affected by the current economic situation and continue to bravely face new risks in the line of duty and for that we are forever grateful;

Whereas, throughout history law enforcement officials have never wavered in the face of crisis or tragedy during uncertain times and they have bravely faced challenges and continue to protect the people of Madison County and the State of Mississippi;

Whereas, the MCBL&F remains committed to ensuring our federal, state, and local law enforcement officers have the resources and support they need to perform their duties safely and effectively;

Whereas, the MCBL&F recognizes and thanks the Mississippi Legislature for its support of law enforcement;

Whereas, the MCBL&F urges all citizens to identify ways to help bring law enforcement officers and the communities they serve closer together;

Whereas, MCBL&F expresses support for the brave men and women of our law enforcement agencies and urging the people of Madison County and the State of Mississippi to back law enforcement agencies.

Now, Therefore, Be It Resolved, that the Madison County Business League & Foundation:

- (1) Recognized the week of May 10 through May 16, 2020, as "National Police Week";

(8) Encourages the people of Madison County and the State of Mississippi to observe National Police Week by honoring law enforcement personnel and promoting awareness of the essential mission that law enforcement personnel undertake in service to their communities in Madison County, the State of Mississippi and the United States of America.
