MADISON COUNTY BUSINESS LEAGUE & FOUNDATION VISION CELEBRATION TIME TO REFLECT ON ACCOMPLISHMENTS OF PAST YEAR

Over 400 Madison County movers and shakers gathered recently for the Madison County Business League and Foundation's 2015 Vision Celebration at the Country Club of Jackson. Jan Collins greeted the business men and women, elected officials and other guests in attendance before the meeting kicked off with music and pageantry as Miss Mississippi Hannah Roberts played the Star Spangled Banner on the violin as the colors were presented.

Bob Williams, who served as co-chair of the MCBL&F for 2014-15, explained the merger with Business League and Madison County Foundation, which occurred December 1, 2014. An Advisory Board of Directors was created with the merger agreement. The legacy of the Madison County Community Trust (501)c3 continues with a separate Board of Directors with the mission of helping education efforts in impoverished areas of Madison County.

Other highlights of the past year include co-hosting an Industry Holiday Luncheon with MCEDA to show appreciation for existing industry in Madison County. The Executive Committee met with mayors, supervisors, and other county elected officials to discuss priority topics for the 2015 legislative session and ways the MCBL&F could help support their efforts on behalf of economic development in Madison County. The 2015 League & Legislature Luncheon had 400 members, guests and elected officials at the in February meeting honoring State Representative Presentations Martinson. given by Governor Phil Bryant and State Treasurer Lynn Fitch. The keynote speaker was Speaker of the House Philip Gunn. The Madison County Business League & Foundation Entrepreneurship SWAT Team was created to assist in mentoring and coaching of start-up companies throughout the state. The MCBL&F hosted the Youth Leadership Class for Quality of Life Day and Government Day and the Board of Directors voted to award \$250.00 scholarships to each of the 2015-16 class members who complete the program. A late afternoon event was co-hosted with

MCEDA to celebrate the renaming of Panther Creek to the Madison County Megasite, a BioTechnology and Advanced Manufacturing Park. Governor Bryant was on hand for the announcement. The Madison County Creative Economy Council hosted the first Madison County Law Enforcement Appreciation Week in May to recognize and show gratitude to law enforcement officers throughout the county and municipalities.

Helping to grow with the needs of Madison County, the MCBL&F and MCEDA boards of directors passed a resolution in support of moving forward with the concept of a new 60,000 square foot conference centers with an adjacent 200 room hotels. The conference center would have a projected impact of more than \$16M in direct spending convention-goers in Madison County. Business leaders and community leaders presented the resolution to the Madison County Board of Supervisors in an August board meeting. Dr. Shannon Campbell, Director of the Trent Lott Center for Economic Development at the University of Southern Mississippi, facilitated an audit of the Madison County Strategic Plan and presented the findings to the MCBL&F which are posted on the website (www. madisoncountybusinessleague.com).

The MCBL&F hosted five luncheons with each level of membership to welcome and share the benefits of membership with the newly merged members. The MCBL&F Education Committee hosted a May luncheon at the Embassy Suites with State Superintendent of Education Dr. Carey Wright who delivered the assessment of public education in Mississippi. Also in May, Central District Transportation Commissioner Dick Hall was the keynote speaker, along with County Engineer Rudy Warnock, for a Transportation Committee luncheon. The MCBL&F Health & Wellness Committee hosted an August luncheon at the MS Hospital Association to enlighten the members on the efforts of each hospital to promote a healthy community and workforce. The Government Relations & Education Committees hosted two luncheons in August and September to inform and educate the business leaders and local elected officials on proposed Initiatives 42 and 42A. Madison County Superintendent of Schools Dr. Ronnie McGehee and School Board attorney Jim Keith spoke on behalf of 42 at Holmes CC and Speaker of the House Philip Gunn spoke at Ruth's Chris on 42A.

In September, speaking to a packed ballroom, US Congressman Gregg Harper was the keynote speaker for the 2015 Coffee with the Congressman luncheon.

Throughout the year, the MCBL&F maintained three websites, including madisoncounty businessleague. com, MCtheroadahead.com and madisoncountycreativeeconomy.com, and produced two newsletters.

Williams passed the gavel to incoming 2015-16 MCBL&F Chair Tina Lakey, who said she's looking ahead to 2016. She said that the MCBL&F has a strong voice in the County. "We are 218 members strong and we will continue to grow as Madison County continues to grow."

Gail Pittman, who serves on the MCBL&F Advisory Board, presented the Visionary Leadership Award to David Landrum. Landrum is a noted Madison County Developer. Noah's Mill has become one of the most exclusive developments in Mississippi. Landrum is responsible for the development of The Town of Livingston, a mixed-use development situated on 480 acres. The development has already had a major impact on Madison County with the creation of nearly 200 jobs. Past recipients in attendance were Joanne Gordon, Joel Bomgar and Dr. David Powe.

Tony Jeff, president and CEO of Innovate Mississippi announced that MCEDA director Tim Coursey had been awarded the John I. Rucker Community Innovation Leadership award at the annual Innovate Mississippi Conference on November 11 in Jackson.

Coursey recognized Joanne Gordon, who has retired from her 26 years as executive director of Canton Convention and Visitors Bureau. "She accomplished much over the years along with her small but dedicated staff and corps of volunteers. She was a pioneer in the film industry in Mississippi. The groundwork of the film industry we have here in the state today was laid by Joanne. For years to come, we'll all enjoy the events she worked so hard to establish, including the Canton Flea Market, Victorian Christmas and the MS International Balloon Festival."

Coursey also spoke about the annual report, and key projects that include TelehealthONE, the Global Training Institute at the Mississippi Bio-Medical Business Collaboratory in Canton.

The Vision Award was presented to Merit Health of Madison. Brett Phelps. CEO of Merit Health Madison, accepted the award. Past recipients include CSpire, Levis Strauss & Company, BankPlus, Nissan North America and St. Dominic Health Services. Merit Health Madison has 113,000 square feet in their facility, and ground will be broken for a new addition in early 2016. Merit puts a strong emphasis on recruiting and retaining exceptional professionals. The company currently employs 277 in Madison location.

Sam Kelly with the Brunini Law Firm introduced the keynote speaker, Lance Nail, Ph.D, CFA, Dean and Professor of Finance at the Jerry S. Rawls College of Business Administration in Lubbock,

Texas. Nail spoke about thinking globally on a local level. He referenced Rich Karlgaard, Forbes Editor-in-Chief and said that industries that will benefit from the emerging global trend of a stronger middle class are industries that are already strong in Mississippi, including agriculture, crop sciences and nutritional sciences. Other industries that will benefit are life sciences, healthcare, energy, technology, innovation coming out of R&D, financial services, and there will be a greater need for banking and investment services as well as lower end automobiles. He told the audience that it was important to build a cluster of expertise in order to know where the comparative advantage. He said that Madison County continued to trend higher than the national average in income, and that leads to a positive economic environment. Nail said we need to be very strategic, targeting healthcare and technology as the best places to invest. He said a strong emphasis needs to be put on a regional workforce development idea which will have broader global implications, as well as specialized manufacturing, which will provide people without college degrees with good jobs. He said that Madison County is well-poised to benefit from a growing global middle class. The demographics, workforce and educational environment here offer a strong balance of both professional and skilled labor. He said we need our own Bill Gates--a champion!

CAN A PETABYTE A DAY KEEP THE DOCTOR AWAY? BIG DATA MAY HOLD THE KEY TO PERSONALIZED HEALTHCARE

Technology likes to show off. It's easy to notice when the latest innovation has arrived because when technology gets better, we notice. In education-tech, we heralded the arrival of the SMART

Board and interactive learning. Governmenttech showed off its ability with advanced NSA surveillance. Every time you see a stunning new Pixar movie, you're experiencing some of the best of entertainment-tech.

But how far have we advanced in the healthtech sector? Think about the last time you visited your doctor. It probably looked pretty similar to the way it looked back when you were excited to get that sick day home from school. You signed in on a clipboard chained to the front desk, filled out your brick of paperwork on another clipboard, and followed the nurse down the hall to the room where she hung the clipboard on the door. The world must have been lawless chaos before the clipboard was invented.

So aside from a few extra computers and iPads at your doctor's office, where are we seeing technology affect positive change in health care? The changes I'm excited about are a little behind the scenes. Let's talk about a couple of them.

Big Data and Personalized Medicine

Everyone knows the marketing world loves to collect data about us. They love to know our preferences and our patterns. It helps them sell the right stuff to the right people. By drawing from a huge pool of data, marketers are able to make very informed decisions. This is Big Data in the commercial world.

Big Data in healthcare is trying to improve your health with that same kind of insight but with less pop-up ads. For a long time, the problem was the data on that clipboard needed to be converted into digital information. In the past 6 years, widespread adoption of electronic medical records (EMR) has provided enough digital medical data to benefit from data analysis. It went from data to Big Data.

It's easy to see how evidence-based medicine is immediately bolstered by Big Data: the pool of available evidence instantly becomes much larger. Doctors now can electronically compare patients' conditions to similar patients and their respective health outcomes. This leads to better diagnoses and better treatment plans because you're working with better intel. Your doctor's perspective is no longer limited to what they're most familiar with. Medical decisions can be more tailored and less standardized. This is the gateway to personalized medicine.

Personalized medicine is still taking shape but has the capacity to really change healthcare delivery. A key tenant of personalized medicine is that the genetic information inside each of us maps out our susceptibility to most diseases. Researchers have begun recording the specific genes of their patients, aka "sequencing their genomes." Combine this genetic info with a personal narrative (diet, behaviors, health history, traumas) and a map legend begins to be formed.

What exactly do all these patients with this very specific type of cancer have in common? What drugs do they respond best to? Big Data could answer this.

But is data analysis really the highest level of general development for health-tech? Is this really state-of-the-art? You'd be surprised. These are huge amounts of data we're talking about.

Petabytes

The Washington Post estimates that the current amount of human genomic data in

existence is around 25 petabytes. That's 2,500 times more data than every piece of text in the Library of Congress. Within the next decade, it's estimated that genomic data will take up more data space than every video currently stored on YouTube. This is all raw data that has to be extracted, curated, compressed, stored, and ultimately made sense of. Only recently has the technology—the algorithms, the processors, the bandwidth—reached a benchmark that could carry such a weight.

It isn't cheap either. But innovation has dramatically lowered the cost. During his battle with pancreatic cancer, Steve Jobs had the genome of his tumor sequenced multiple times to help decide which drug therapy to use. According to the New York Times, each sequence cost him \$100,000. A decade earlier, in 2001, it would have cost \$100 million.

Now, just 4 years after his death, it costs barely over \$1,000. That is a remarkable cost reduction resulting purely from an improvement in technology.

Not only is DNA sequencing more efficient and cost-effective than ever before, but it's also becoming more share-friendly. Fast Company reports that just last month the FDA released a website, precision.fda.org, that makes it easier for researchers to explore the existing community-based genomic information. This DNA library makes it easy for scientists to collaborate with each other, share genomes they've sequenced, and build off of each other's discoveries. This socialization of genomic research, combined with the power of Big Data, is important. Some experts believe it's the way we're going to cure the big diseases.

So, we know Big Data analytics has the power to radically personalize medicine. But how are these broad concept macro-innovations being fueled on the ground level?

Sensors

In the past five years, we've seen a huge rise in the popularity of activity trackers. There's a good chance you use something like a Fitbit, and if not you definitely know ten people who do. Such rapid adoption has encouraged companies and their engineers to innovate and make products that give us more and more insight on our health metrics and help us live healthier lives.

But what about the really chronically sick? Sensor technology has an even bigger opportunity to help these individuals. In August, Y Combinator—a Silicon Valley incubator for startup companies—released their "Request for Startups" report. In their healthcare section they state:

6.6 Healthcare in the United States is badly broken. We are getting close to spending 20% of our GDP on healthcare; this is unsustainable.

We're interested in ways to make healthcare better for less money, not in companies that are able to exploit the system by overcharging. We're especially interested in preventative healthcare, as this is probably the highest-leverage way to improve health. Sensors and data are interesting in lots of different areas, but especially for healthcare. ??

This is the most prestigious startup accelerator in the country. Only 3 percent of the companies that apply to participate in their program are accepted and they've made an explicit request for innovators to explore the possibilities and the promise through use of sensors and data in healthcare. They see a gap and an opportunity.

In 2014, C Spire partnered with the University of Mississippi Medical Center in a pilot program to improve healthcare in rural Mississippi through remote monitoring and data analytics involving individuals with diabetes. Thousands of people in our state suffer from more than one chronic disease and live outside the reach of consistent quality health care. Our plan combined the power and

ubiquity of our high-speed mobile broadband communications network with Intel-GE sensors that link UMMC specialists to patients in their homes to deliver more connected, collaborative and cost-effective care. Patients are issued tablets and sensors equipped to monitor metrics like glucose levels, provide educational health information, and transmit a seamless stream of data to specialists at UMMC.

UMMC estimates \$339,000 in combined savings for the 100 patients in the diabetes pilot program, resulting from the elimination of hospital stays and emergency room visits. Assuming 20 percent of Mississippi's diabetic population enrolls, this could add up to \$189 million in Medicare savings for our state every year.

In fact, that pilot was so successful that C Spire, UMMC and Intel-GE Care Innovations have agreed to partner together on a five-year program that promises to dramatically lower the cost of care and improve the health of thousands of chronically ill and underserved consumers in the southeastern U.S.

This approach helps to close the gap between the medically underserved and everyone else. This saves our state a significant amount of money. This even promises better health outcomes for the many individuals who struggle with chronic diseases every day. This is the medical equivalent of Fitbit, but with much higher stakes.

So as far as health-tech goes, with Big Data and sensors, we're in a pretty good place. And if history is any indicator, we'll soon be heading to an even better one.

JOHN I. RUCKER COMMUNITY INNOVATION LEADERSHIP AWARD PRESENTED TO THE MADISON COUNTY ECONOMIC DEVELOPMENT AUTHORITY
