#### MADISON COUNTY ECONOMIC DEVELOPMENT AUTHORITY REPORT

In the fall of 2016, the Madison County Economic Development Authority (MCEDA) determined that, in keeping with our business and industry partners, we needed to focus on the practice of continuous improvement. Persuant to

our commitment to being a highly effective organization, we commissioned a competitive economic development assessment designed to help identify our organizational strengths, weaknesses in addition to potential opportunities and threats to our goal of raising the standard of economic development in our area.

MCEDA selected VisionFirst Advisors to conduct a competitive review of economic development in Madison County. The VisionFirst team compiled an overview of the current conditions, ultimately addressing the question, "where is the community now and where does it want to go?" MCEDA re-

ceived the competitiveness assessment in April 2017. There is an action plan for carrying out the strategic initiatives set forth in the report with the

over-arching goal of MCEDA continually operating as a highly effective economic development organization. The strategic initiatives include: Competitiveness, Business Formation, Business Retention and Expansion, Education and Workforce, and the cross cutting automotive industry initiative.

On Wednesday, May 24th, the Madison County Economic Development Authority

hosted a joint meeting with the Madison County Supervisors to present the findings in the Competitive Economic Development Assessment Report prepared by VisionFirst

> Advisors. During the meeting Gray Swoope, President & CEO of Vision-First Advisors, gave an overview of the report. During the overview, Mr.

Swoope provided best practices, recommended additional staff, outlined a program of work, and established baseline metrics for MCEDA. After the presentation, there was a question and answer portion of the meeting. Additionally, Griff Salmon, Principal of VisionFirst Advisors, discussed the steps in the executive search process leading to the selection of a new MCEDA Executive Director.


